

## **WEBSITE PRIVACY POLICY**

#### 1. DEFINITIONS

In this Policy the following terms have these meanings:

"Cookie" means a small text file placed on your computer or device by the 1g dynamics website when you visit its website;

"1g dynamics website" means this website, www.1g-dynamics.com

# 3. WHAT DATA DOES 1g dynamics COLLECT?

Some data will be collected automatically by the 1g dynamics website. Other data will only be collected if you voluntarily submit it.

Automatically collected data, which includes data collected through Google Analytics, will be non-personally identifiable data.

Data collected that you have voluntarily submitted may be personally identifiable data.

Depending upon your use of the website, 1g dynamics may collect some or all of the following data:

- 1. Name
- 2. Business/company name
- 3. Email addresses
- 4. Telephone number
- 5. Enquiry message
- 6. Browsing stats and behaviour via Google Analytics (automatically collected)



# 4. HOW 1g dynamics USES THE COLLECTED INFORMATION

1g dynamics uses the information collected from you in a variety of ways depending on the permission or consent that you have granted. This includes:

### **Operations**

1g dynamics uses your collected information to provide the services and information that you request and to respond to your enquiries, comments and questions.

**Google Analytics:** 1g dynamics uses Google Analytics to monitor traffic levels, search queries and visits to its website.

#### **Google Analytics**

1g dynamics uses Google Analytics to measure and evaluate access to, and traffic on, its website and to create user navigation and behaviour reports for its website administrators and marketing team. Data collected from Google Analytics is not attributable to an individual.

#### 5. STORING AND SHARING YOUR DATA

#### Does 1g dynamics retain your data?

1g dynamics only keeps your data for as long as required in order to use it as described in Section 4. Data may also be retained for as long as you have given your permission, such as sending you 1g dynamics' newsletter.

#### Where does 1g dynamics retain your data?

Personally identifiable data that you submit through the 1g dynamics website will not be stored or transferred outside of the European Economic Area ("the EEA") (The EEA consists of all EU member states, plus Norway, Iceland and Liechtenstein).

Your data may be stored in the following areas:

**1g dynamics Office -** Your data is stored securely on 1g dynamics' internal, secured Company network.

**Website Server -** Some data, such as your name and email address may be stored on the 1g dynamics website or within the Company's internal email marketing software system. Ig dynamics does not hold any sensitive personal data on its website, which is hosted securely running under HTTPS.



**Website Backup Servers** – 1g dynamics regularly and securely backs up its website. Some data, such as your name and email address may be stored on 1g dynamics website backup servers. Ig dynamics does not hold any sensitive personal data on its website.

### Will my data be shared?

1g dynamics will not share your data with any third-party without your permission.
